As per power conferred in the sub-section (2) of the section 4 of the "Assam Non-Govt. Educational Institution (Regulation and Management) Act./2006" and Rule-3 of the "Assam Non-Govt. Educational Institution (Regulation and Management) Rules/2007" prior permission is hereby accorded to ST. Anthony's School, College Nagar, PO, Abhoypur, North Guwahati-31, District-Kamrup (Assam), subject to the following conditions:-

- 1. Any deviation noticed in regard to terms and conditions prescribed in the rules, the prior permission will be cancelled.
- 2. The School authority have to submit Annual Report regularly to this Directorate.
- 3. The School authority shall constitute the Managing Committee as per RTE Act./2009.
- 4. The School authority shall apply for Registration of the School in Form-II within a period of 1 (one) year alongwith the copies of all documents.
- 5. The School authority cannot claim any financial benefit from the Govt. on the strength of this order.
- 6. The teaching staff must have requisite academic qualification and training mentioned as per NCTE guideline.
- 7. Fire safety measures must be available in the institute.
- 8. Admission to be institution shall be open to all without any discriminations based on religion and other issues.
- 9. The institution shall follow approved courses and curriculum and fulfill other provisions mentioned in the RTE Act./2009.
- 10. The accommodation shall be sufficient for the classes conducted in the institutions.
- 11. Arrangements shall be made for the supply of good drinking water to the students.
- 12. The arrangement in the building or other structure must be healthy and hygienic.
- 13. Entrance and exit of the Multistoried school building should be sufficiently wide in case of emergency wherever necessary.
- 14. The school building should be established by the side of a road or by lane not less than 22fts in breadth.
- 15. The school authority should not allow to parking of vehicles in front of the school gate.
